### VI. Questions and Answers (25%):

1. What are the purposes of exporting or shipping documents?

The documents known as export or shipping documents are required for multiple purposes. One major purpose of the documents, in general, is to provide the foreign customs authorities with a complete, detailed description of the goods so that the correct import duty can be levied. Some documents are required to spell out contractual rights and duties of the parties concerned; some are required to satisfy government stipulations of exporting and importing countries; others are required for the administration of exchange control regulations or import quotas in the product, and to safeguard the public and animal health and prevent the spread of plant diseases.

#### 2. What's "physical delivery"?

We call the simple exporting or shipping goods to the foreign countries "physical delivery".

3. What is the significance of a contract in a business process?

Business as we know today would be impossible if there was no agreement or contract to bind the contracting parties. The importance of a contract in an international sales transaction cannot be underestimated. Often it is the only document



between the parties to which they may refer for clarification of mutual responsibilities, resolution of disputes, in the event of disagreement. Such a contract serves as a 'living document' that may well survive the relationship it defines.
